## 3. OLD BUSINESS

## 3.a. Signal Box Wraps, Nicole Delfino

Elizabeth has researched and curated archival photos of Dunedin to educate and entertain the general public on the history of Dunedin. The Signal Box Wraps project has been expanded to include 3 boxes on Patricia, 2 on Main Street, and 6 on 580/Skinner. The images will be presented to the Commission on a future date after review by city administration and ACAC. Once the project is approved by the Commission, the Patricia boxes will be the first to be installed while the remaining boxes must be reviewed and approved by the state.

### 3.b. Artwork Conservation/Annual Maintenance, Elizabeth Brincklow

St. Cate Fine Art costs for annual maintenance of the collection will not increase for FY2025. Note annual maintenance costs for artwork are currently in the budgets of each department where the artworks are located, ie. Parks and Rec, CRA, Library. In discussion with the city, these costs will now be centralized to consolidate the process. A schedule for annual maintenance for our artworks has been requested of St. Cate.

**3.c.** The Leland Chase Outdoor Gallery, **Karen Rader (Subcommittee Chair)** The subcommittee and ACAC recommended artist images for the project were presented

Please note costs for materials and labor did increase for a total project cost of \$4,868.56 for the nine artist images and one signage image. Installation is estimated for late April or May.
