





Water Production

- Train #2 waiting on new VFD, expected delivery date is 1/31/2024 and membranes to be installed following, Train #3 needs membrane cleaning. New cleaning in place is 90% complete.
- Augmentation has reached our allowable compacity for the year (60MG).
- SWFWMD declared a Water Shortage for Pinellas and surrounding counties effective December 1, 2024.

Water Distribution

- City of Dunedin Sailing Center: Construction complete, project close out.
- Santa Barbara Brick Street: Construction complete, project close out.
- Library Landscape Upgrades: Bid came in over budget. Work being completed with in-house staff.


