

City Manager's Update

April 6, 2023

This Update will refer to the events since the date of the last Update of March 10th and is covering the updates and statistics for the month of March~

Marina

- Marina usage for March 2023:
 - Daily Ramp Passes (Office payments): 6
 - Daily Ramp Passes (Kiosk payments): 110
 - Daily Ramp Passes Total: 116
 - Annual Resident Ramp Decals: 20
 - Annual Non-Resident Ramp Decals: 0
 - Transient "Visiting" Boaters: 5

- On March 9th, the City Commission voted to approve a rate increase of 10% for all marina slip users. The increase is effective beginning on April 1, 2023.
- Supplies for the replacement of electric panels throughout the marina are still on backorder. The manufacturer continues to be hopeful that the supplies will arrive by the end of April.
- Purchase orders have been processed by the State of Florida for removal of three at-risk and derelict vessels in and around the marina. Once approved, these vessels will be scheduled for removal and destroyed.

CRA/ECONOMIC & HOUSING DEVELOPMENT

FY24 Budget Preparation

- Staff spent considerable time this month preparing Capital Improvement Project (CIP) and Business Plan Initiative (BPI) work sheets in preparation of the FY24 Budget and CRA Long Range Plan.

Community Redevelopment Agency (CRA)

- Staff has completed the FY 2022 CRA Annual Report and Audit. A request for approval is scheduled at the March 23rd at the CRA Agency meeting.
- The CRA Advisory Committee recommended new members and elected new officers at the March 1, 2023 meeting. The Chair is John Freeborn and the next meeting is scheduled for May 3rd. Staff continues to support and assist this vital Committee.
- Staff continues to address ongoing enhancements to the downtown, such as benches, signs, dumpster enclosures and landscaping.

CRA Sponsored Special Events

- The Friday/Saturday weekly Tampa Bay Market continues to be well attended. Summer hours will start June from 9:00am to 1:00pm at Museum parking lot.

Downtown Projects

- **Gateway** - The Gateway Development project is due to break ground late Spring of 2023. A meeting with the Developer is being scheduled.
- **Existing City Hall** - staff is working with Public Works on the demolition of the old City Hall scheduled for this Summer.
- **New Parking Garage** - Staff is preparing additional information for the April 4th City Commission Workshop, where several major projects will be discussed and overall Financial funding plan will be reviewed.

- **Skinner Blvd Road Project** - Staff is working with FDOT to address questions and comments on the 30% Design Plan.
- **Downtown Streetscape Pavers enhancements** (Phase 1 on Main Street, Casa Tina) Staff is waiting for the final design plan from the Consultant before moving to an RFP on the project. Construction is anticipated in the Summer of 2023.
- **Mease Materials** – demolition of the building is scheduled for the week of March 20th. The parking lot will be closed for approximately two months during the demolition.

Coca-Cola Site

- Staff continues to attend the monthly dialogues with representatives from Coca-Cola and reports that the Dunedin plant will close in the Fall 2023 and marketing of the property would occur Summer of 2024.
- Staff is participating in the (TEILS) County Advisory Committee to review the Target Employment and Industrial Lands Study, especially as it pertains to the Coca Cola site.

Marketing and Communications

- Staff meets weekly with the Communications department to assist with promoting greater communication between internal departments, citizen and business organizations.

Facade Grants

- Staff continues to work with several local businesses on commercial facade grants. To date seven commercial facade grants have been awarded.

Patricia Corridor Project

- The landscape median had a bid opening on February 28, 2023. Staff is working with Public Works to assist with managing some of the cost associated with this project.

Business Recruitment and Retention

- Staff continues to meet with and assist the Dunedin Downtown Merchants Association (DDMA), and Visit Dunedin.
- Staff continues to work with Pinellas County Economic Development (PCED) and attend the monthly Economic Development Partners meetings with leadership from the surrounding municipalities.
- Staff continues to respond and to assist businesses to find available space in the business community.

Affordable Housing

- Staff continues to explore opportunities to create affordable housing.
- Staff continues to field calls from citizens seeking resources for affordable housing and other social services.

SUSTAINABILITY

Program Coordinator:

- City Commissioners and staff attended the Blue-Green Connection's Hope Spot Gala at the Fenway Hotel in March. The evening was filled with educational speakers who provided regional and state-wide updates on marine ecosystems, the state of coral reef health, best practices for conserving local waters, and ways the community could become more involved. Natalie Gass, the City's Sustainability Program Coordinator, presented on ways the City of Dunedin is moving forward on its sustainability journey.

PARKS & RECREATION

Parks & Recreation Administration:

- Finalized the FY 2024 budget requests for the Parks & Recreation Department including all operations, capital improvement projects, business plan initiatives, and personnel requests for fourteen (14) cost centers and areas of operation.
- Conducted a review of the Highlander Aquatic Complex Master Plan and phasing options at the City Commission Workshop on March 7, 2023. The funding options will be discussed at the City Commission Workshop on April 4, 2023.
- Received the bid opening for the replacement of the Pram Shed on March 14, 2023. The bid award by the City Commission is scheduled for April 18, 2023.
- The Master Plan for the Dunedin Golf Course Restoration was presented to the City Commission at a workshop on March 21, 2023. Funding options will be discussed at the City Commission Workshop on April 4, 2023.
- Continued to work with the new General Manager of Golf Operations, Blair Kline and the transition to City operations. Met with the Facilities Department to discuss the maintenance facility needs as well as building services including custodial contracts. Staff are working to develop the budget for the DGC for fiscal year 2024.
- Staff continue to work with the City Attorney on the development of a Transition Agreement between the City of Dunedin and Dunedin Country Club, Inc. for required services through 2024. Additionally, the Transition Team continue to meet on a weekly basis and are finalizing plans for capital improvement projects, hiring new personnel, contractual agreements, and a communications plan for both the transition and the course renovations.
- The City has advertised for bids for the maintenance of the Dunedin Golf Course. The bid opening was held on February 28, 2023 with three (3) bids and one (1) bid that was non-responsive. The award of the contract is tentatively scheduled for City Commission approval on April 4, 2023.

Marketing:

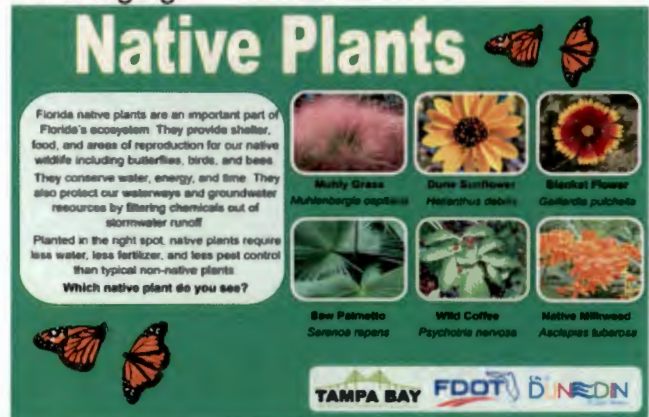

 Provided both contractors a copy of the City of Dunedin's Stormwater Compliance Ordinance a requested that they maintain all erosion control in order to stay compliant with their site plan.
- Creating Standard Operating Procedures (SOPs) for all activities under the MS4 Stormwater permit.
- Developing an Illicit discharge training for staff. This will ideally start in the Summer of 2023.
- Formatting data to be submitted into the FDEP WIN water quality database.

Stormwater Compliance

 - 1– brought into compliance/ stormwater education provided

Solid Waste & Recycling Division:

- 1,413 tons of residential waste safely collected from curbside customers.

- 13,000 residential recycling carts safely collected by the City's residential recycling contractor, Waste Pro

UTILITIES DEPARTMENT:

Engineering Division:

Utilities Section

- **Water Treatment Plant – Design-Build**
 - The Water Treatment Plant (WTP) Refurbishment Project will rehabilitate/replace the existing 9.5 MGD treatment plant and ensure the ongoing production of high-quality potable water to the City of Dunedin's residents and customers. The Water Plant experienced a fire that was contained, and fortunately did not result in an interruption in providing safe potable water to the residents of Dunedin. The damage is being repaired.
 - Restoration activities continued through the month of March.
 - RO Skid final wiring of electrical disconnects and control panels is anticipated to continue through April.
 - Final wiring for large gage wires is underway; terminations pending delivery and installation of electrical gear.
 - Final wiring of the Flush Tanks and associated instrumentation was completed. Operation of the system is pending repair of the I&C system.
 - CIP tanks fabrication and installation continues, with associated assembly of the system to follow in April.
 - The City is working with the original contractor to insure final complete all items of the refurbishment project contract in order to arrive at substantial completion.
- **Lift Station #20 & #32 Rebuild Project**
 - Both lift stations are undersized, prone to overflow during heavy rain events, and adjacent to waterways. The rebuild of these lift stations will be appropriately sized, provide emergency backup pumping, and reduce impacts on public waterway channels.
 - LS #32 -- final bid package is complete, and approval from the state for the release of grant funds is pending. It is anticipated that construction cost will be greater than the engineers original estimate and will require an increased funding cap from FDEM.
 - Lift Station #20 – the construction contract was awarded by the Commission during their meeting of 3/21/23. The City has approached FDEM for consideration of additional HMGP funding due to increased construction cost escalations.
- **Wastewater Lift Stations Electrical & SCADA System Upgrades**
 - This project consists of upgrades to the City's existing electrical control panels, Programmable Logic Controllers (PLCs) and SCADA application at the City's lift stations in the Collections system. The work includes; materials, installation, testing, and commissioning of existing Local and Remote Telemetry Units, PLCs, network equipment, power supplies, terminal blocks, wire, wire ways, surge suppression, cellular communication modems, mounting hardware, and computers.
 - The contractor has begun the submittal process for the procurement of materials to be assembled and installed.
- **Wastewater Lift Station #20 Forcemain Replacement**
 - This project will replace the aged forcemain from Lift Station #20, constructed from a thin-walled PVC pipe which is prone to breakage. A portion of the forcemain is located outside the CR-1 roadway surface, recently resurfaced by Pinellas County.

Parallel to the forcemain replacement, the City installed a Fiber Optic line to the new Emergency Operations Center, reutilizing portions of the existing forcemain as a conduit for the new Fiber line to reduce overall construction costs.

- The Fiber Optic project is 100% complete. Conduit has been installed. Cable has been installed to the Public Services building and the Emergency Operations Facility and a lateral line has been installed at POC and Belcher Offsite Water Storage Facility.
- The Forcemain project is being redesigned by the awarded Contractor's engineer, for directional drilling along the alignment. The updated plans have been submitted to the City's Engineer of Record for review and comments.
- **Wastewater Treatment Plant (WWTP) – Electrical & SCADA System Upgrades**
 - The City intends to replace the Motor Control Centers (MCC's), switchgear, breakers, localized generators, Programmable Logic Controllers (PLCs), and related electrical equipment at its WWTP and the electrical equipment, starters, etc. The electrical equipment at the WWTP and lift stations has reached the end of its useful life, and maintenance has become difficult to perform, with parts being a challenge to acquire. Installation of this new equipment increases safety measures for operational and maintenance staff.
 - The bid package was re-advertised with the SCADA portion removed (see above). Bids have been received. The bid prices exceeded the Engineering Opinion of Probable Cost. A request has been submitted to FDEP for SRF review regarding an increase in the funding amount for the project. A determination is expected by the end of August 2023.
- **Wastewater Treatment Plant (WWTP) – Chlorine Contact Chamber Rehabilitation & Cover**
 - The City intends to rehabilitate the WWTP Chlorine Contact Chamber (CCC). Tank lining will be removed and replaced. Gates and valves will be rehabilitated and replaced as necessary. This will require augmentation of process flow via bypass pumping and alternative chlorine contact storage.
 - The City has contracted with Arcadis to design a cover for the CCC to help prevent the growth of algae and the degradation of chlorine via UV rays from the sun. Arcadis has been instructed to re-evaluate design constraints to provide design that will fall within budget constraints.
- **Wastewater Pipe Lining & Manhole Lining Projects**
 - These projects provide for the installation of liners for pipelines and manholes throughout the City to reduce and prevent inflow and infiltration (I&I) of groundwater and rainwater into the City's sanitary sewer collection system, thus reducing the potential for sanitary sewer overflows (SSOs) and treatment impacts at the Wastewater Treatment Plant.
 - The FY22 pipe lining project is essentially complete. Emergency repair locations were added to the overall project prior to close out of the 2022 program.
 - FY23 Lining area has been generated and has been reviewed by the City Attorney for acceptance as "Piggyback" contract work. The presented contract was denied due to policy issues. Another compliant contract for piggyback is being researched.
- **Wastewater Forcemain Replacements Project**
 - This project provides the design and installation of six (6) new PVC and/or HDPE forcemains (#1, 2, 4, 10, 12A, & 17) with all valves, fittings, and appurtenances; and the abandonment of the existing forcemains.
 - Design of the forcemains is complete all permits have been approved.
 - An Agenda Item has been scheduled for the 4/18/23 Commission Work Session to utilize a Piggyback award to TLC's contract with Pinellas County. Construction is

expected to commence during the Summer of 2023 depending upon material availability.

- **Curlew Reclaimed Water Tank**
 - This project provided for the removal of loose paint, restoration and / or replacement of corroded steel parts and piping, and recoating with a durable paint system with artwork.
 - Artwork on the tank has been completed.
 - Onsite visit and coordination with Verizon/Nokia has begun to determine final placement of cellular equipment.
- **Offsite Potable Water Storage Site Valve Replacement**
 - This project provides for the replacement of in ground valves, check valves, and fill valves at offsite Potable Water Storage sites.
 - A site visit has been conducted with a contractor to evaluate the project.
 - A quote has been provided via piggyback of a Pinellas County contract. The proposed work exceeds the existing budget. Funding opportunities are being investigated and with the project potentially being budgeted in FY24.
- **WWTP 10,000 Gallon on Site Diesel Fuel Tank**
 - This project provides for the replacement of the 10,000-gallon diesel fuel storage located at the City's WWTP. The existing tank is reaching the end of its useful life and should be replaced in the near future.
 - Engineering/WWTP are seeking sole source procurement to address the safety, design and location characteristics / constraints and possible options.
- **Wastewater Treatment Plant Outfall Piping Repair**
 - The intent of this project is to improve the WWTP's outfall system's reliability, redundancy and safety.
 - The project has been submitted and added to the House Appropriations (\$400,000 request) list and issued a form number.
 - Should such funding become available, staff will research the availability of a compatible piggyback contract to comply with City Purchasing Policy.
- **Water Production Well Facilities (Well 1)**
 - This project provides for the rehabilitation of raw (potable) water wells, including Well #1. The well has exceeded its useful life, and requires rehabilitation to continue viable water production.
 - 100% design plans have been received. Bid documents are finalized for advertisement.
 - A contractor quote has been requested via "Piggyback" of a Pinellas County contract. The proposed work is expected to exceed the existing budget should the project be advertised. The "Piggyback" quote is being requested in an effort to compare fiscal requirements.
- **Raw Water Transmission Line Pigging**
 - This project provides for the cleaning of all the raw water transmission lines for the City's wellfield. The accumulation of soils, silts, deposition of organic matter, and precipitation of materials necessitate the pigging requirements to maintain flow and reduce system contaminants and early degradation.
 - A contractor quote has been received via "Piggyback" of a Pinellas County contract. The proposed work is expected to meet the budget constraints of the project.
 - City staff are evaluating the operational viability to maintain the minimum requirements for the City's Water Distribution System and Water Treatment Plant.

New Construction

• New City Hall

- The New City Hall building houses the City's Commission, technical, financial, planning, billing, and administrative services. The new facility will help streamline City processes and make services for visitors, residents, and customers more convenient.
- City staff occupied the building in mid-March 2023 as a result of a Temporary Certificate of Occupancy (TCO) which was issued to the contractor for the Administrative portions of the building.
 - The Contractor, Manhattan Construction, continues working on the Commission Chambers portion of the building, in an effort to achieve Final CO / substantial completion.
 - Final Punch List items are documented by City staff, the project Architect (Harvard Jolly), as well as the contractor.
 - Several trades remain on site as the project moves towards final substantial completion and final CO.

Roadway Section

○ Santa Barbara Brick Street

- The bid for the project was advertised in December with a submittal date of January 10, 2023. A non-mandatory pre-bid meeting was held on December 22, 2022.
- Submittals were received and evaluated and the lowest qualified bidder was Evolution Contractor's out of Clearwater FL.
- References are complete and project was awarded on February 21st.
- Agreement is signed and Notice To Proceed has been issued for April 17, 2023.
- Residents have been contacted by contractor.

○ FY23 Pavement Program

- Gator Grading and Paving was awarded the contract in November. The Agreement has been approved.
- The pre-construction meeting was held on December 15th.
- Notice To Proceed has been issued and work began January 9th.
- All work is done with the exception of the final thermoplastic paint (which can't be applied until 30 days after paving).
- Project to be completed by end of April.

Drainage / Interdepartmental Support

- **Brady Drive:** DRMP, Inc., (one of the City's General Engineering Consultants [GEC] firms) previously prepared a Preliminary Engineering Report (PER) to investigate elevating Brady Drive and conveyance alternatives where Jerry Branch passes under the road. The PER provided a preliminary cost estimate to improve the level of service (LOS) for Brady Dr., with staff selecting a 10-year LOS for design. Following the advertisement of a 'Request for Proposals (RFP) to provide design, permitting services, and construction documents preparation, DRMP was selected and awarded a contract by the Commission on October 13. DRMP has completed the initial survey and Subsurface Utility Engineering (SUE) work and held the pre-application permit meeting.
 - DRMP conducted a structural inspection of the existing culverts and headwalls. While the structure is stable, it is approaching its useful life expectancy and needs to be replaced. In addition, the immediate downstream section of the creek is eroding and needs to be armored.
 - The initial design to widen and elevate the section of road crossing the creek was rejected as the property owners on the south side of the road did not want to grant easements necessary to widen and elevate the road. DRMP was then directed to

replace the structure in-kind (same height and width). This caused a several month delay.

- DRMP is finalizing the plans and obtaining all regulatory approvals.
- The project is expected to be bid in March 2023.
- **Pickleball Courts:** The Parks Division requested engineering support to design and provide cost estimates for constructing Pickleball courts. Eagle Scout Park was initially looked at, but as the open area where the courts would go was previously used as a landfill and the underlying soils are not adequate to support the courts. Parks is looking at other locations, with Stirling Links providing the most advantageous attributes of open space, parking and drainage.
- **San Charles Drive Drainage Improvements:** This drainage improvement project is slated for construction in FY23. The purpose of this project is to provide a roadway level of service (LOS), 10-year / 24-Hour, for the intersection of San Charles Drive and San Roy Drive South. The status of the project is as follows:
 - A title search was ordered and submitted to the City in February 2022.
 - Preparation of the construction plans is in process.
 - Plans were sent to utilities for review & comment.
- **Santa Barbara Drive Drainage Improvements:** This drainage improvement project is slated for construction in FY24. The purpose of this project is to provide a roadway level of service (LOS), 10-year / 24-Hour, for Santa Barbara Drive, from 200 feet north of San Salvador Drive to Bueno Vista Drive South (approximately 1,800 feet). The status of the project is as follows:
 - City staff is working with the architect for the property owner at 1768 Santa Barbara Drive to vacate an existing utility easement and coordinating with the property owner's surveyor to prepare a legal description for a new easement.
 - Construction plans are in preparation for the new outfall associated with the previously referenced address. This outfall will be up-sized as a part of the proposed drainage improvements for Santa Barbara Drive.
 - Preparation of the construction plans is in process.
- **Buena Vista Drive Drainage Improvements:** This drainage improvement project is slated for construction in FY24. The purpose of this project is to provide a roadway level of service (LOS), 10-year / 24-Hour, for Buena Vista Drive from Mira Vista Drive to 600 feet northeast of Mira Vista Drive.
 - Preparation of construction plans is in process.
- **Downtown East End Plan (DEEP) - Mease Materials:** This parking lot reconstruction project is slated for construction in FY23. The status of the project is as follows:
 - Demolition of the existing building is complete.
 - A temporary Millings Parking Lot will be created with internal forces (Public Services) following site demolition work.
 - Engineering is in the process of developing construction plans for permitting and future bidding of a permanent Parking Lot, subject to funding availability.
- **Gabions Drainage System Repair:**
 - Pennoni Associates, Inc. is under contract (7/13/21) with the City to evaluate, prioritize and prepare construction plans for the repair of the gabions.
 - Approximately 900 ft. of gabions are to be designed and permitted for repair. The repairs proposed are located between Pinehurst Road, Jackmar Road, Patricia Avenue and Idlewild Drive South.
 - Survey by Pennoni has been completed with geotechnical testing by Tierra of the gabions and ditch.
 - 60% construction plans and environmental permit packages have been submitted and are being reviewed by the City and regulatory agencies.

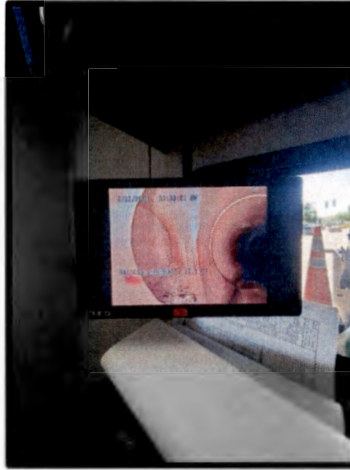

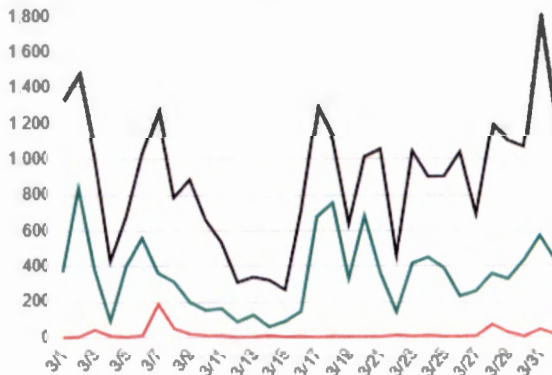

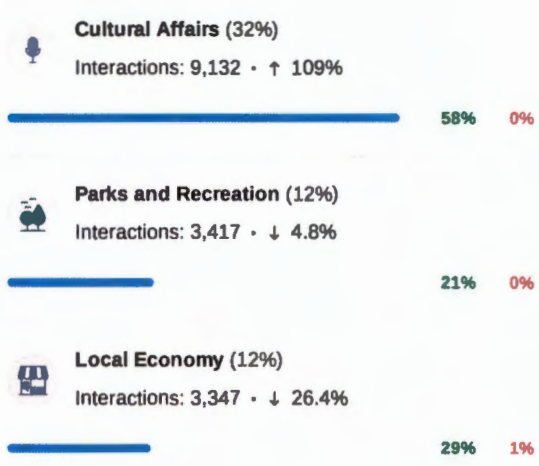

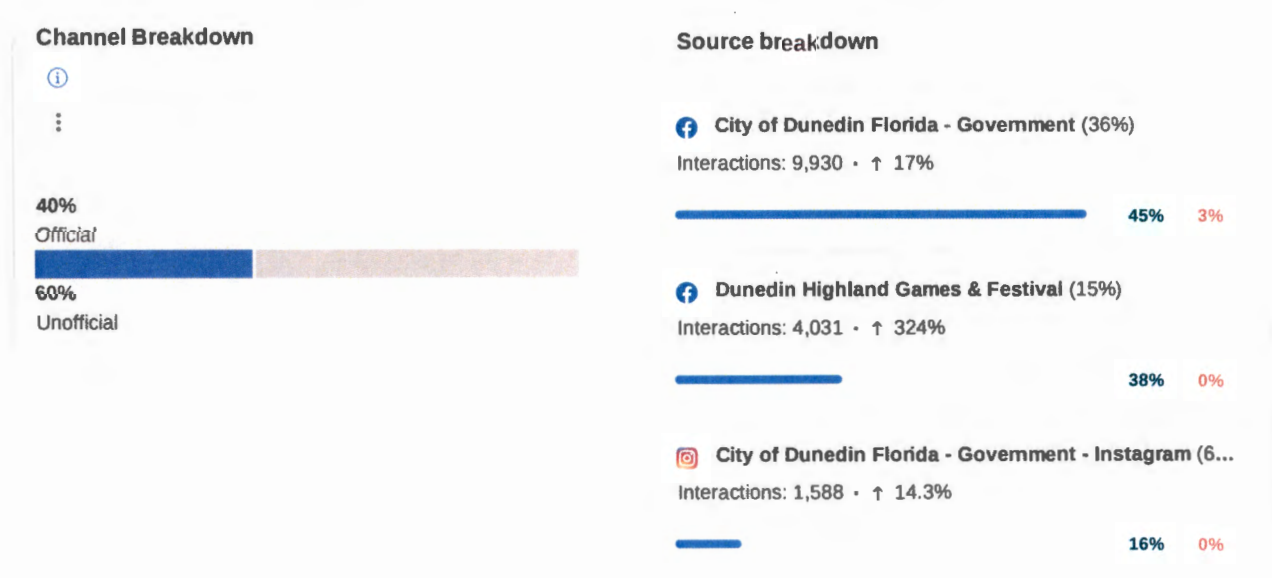
