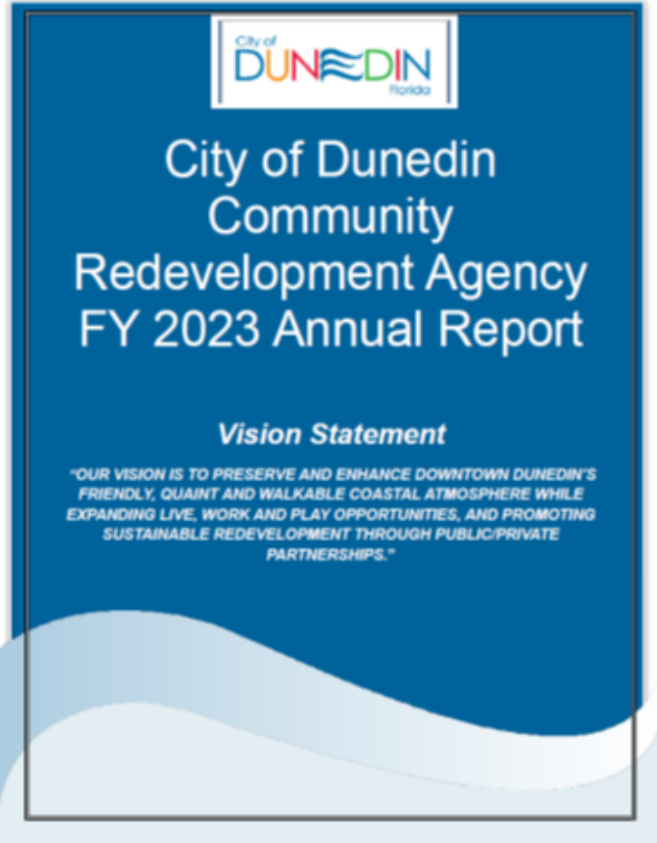

CRA Annual Report



Downtown Projects

- **Mid-Town Garage** - Staff is working on a design/build scope for the new garage on Douglas Avenue and Scotland Street.
- **Old City Hall** - the demolition and stabilization of old City Hall building is complete. Work is now focused on a design plan for the site.
- **Skinner Blvd Road Project** – The Project Letting (Bid) is scheduled for May/June 2024. Construction is scheduled to commence early 2025.
- **Downtown Streetscape Paver Enhancements** - The second phase of this initiative will improve walkability and overall aesthetics on the south section of Main Street from to the Pinellas Trail to Broadway. Phase II is scheduled to start this summer/fall.

Community Redevelopment Agency (CRA)

- The CRA Advisory Committee is scheduled to meet 3/6/2024 and the CRA on 3/7/2024.
- The CRA Annual Report will be presented at the March 7th meeting and will be available on the City Website after CRA approval.

Special Events and Projects

- The Tampa Downtown Market at John R. Lawrence Pioneer Park and continues to be well attended.
- The next Arts and Craft Festival is scheduled for April 20 & 21, 2024

Economic Development Practitioners Meeting

- Staff will host the next meeting at City Hall on March 14th 2pm. The quarterly meeting is attended by Economic Professionals from Municipalities throughout Pinellas County.

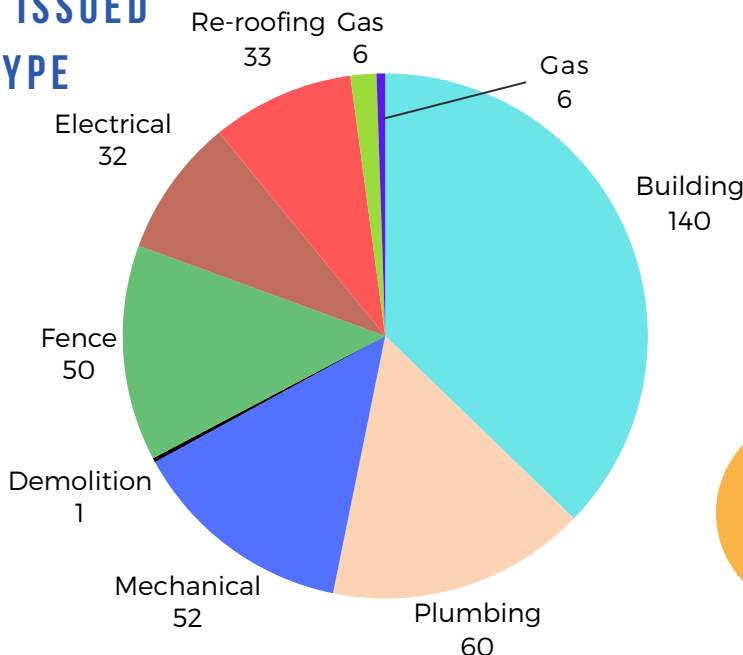

- **FY24 Mill & Overlay Contract:** Project to be awarded for construction to Asphalt Paving System, Inc. Preconstruction meeting held February 28, 2024. Construction to start late March.
- **Pavement Management System RFQ:** Project currently advertised to obtain a firm to provide software, training and evaluation for Dunedin's asphalt roadways. Proposals to be received April 2, 2024.
- **Washington St Flooding:** Under design by consultant, DRMP. 60% plans due April 15, 2024 with bid package ready for submittal to procurement June 15, 2024.
- **Gabions Drainage System Repair:** Consultant, Pennoni and Associates, prepared 100% plans. Bids docs being prepared. Plans to be advertised for construction August 2024.

Utilities Projects in Progress

- **Lift Station 32 Rebuild:** Design complete. Awaiting FEMA/DEM approval and grant funding of construction phase.
- **WWTP Electrical:** Bids received exceed cost, twice. Design team and City evaluating options.
- **WWTP SCADA System Upgrades:** Only one bid received. Bid was rejected due to lack of bidders. Project to be re-advertised early summer.
- **WW Lift Station Control Panel / SCADA replacements (44 sites):** Construction at multiple sites.
- **WWTP Chlorine Contact Chamber Rehab:** Project awarded for construction, preconstruction meeting scheduled for March 11, 2024.
- **WW Force Main Replacements:** Forcemains for LS #12A / Fairway Dr. and #4 / Santa Barbara Dr. are underway. Forcemain for LS #2 work will commence along Douglas Avenue at the intersection north of Scotland Street for manhole installation from March 11th to April 1st. LS#10 work in progress is along Virginia Lane.
- **WWTP Outfall Piping Repair:** Grant Agreement from FDEP for \$400K approved by Commission on October 31st, 2023. Preparing bid package for construction. Targeting March 2024 for advertisement.

Dear Jennifer, Jorge & Mark:

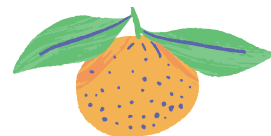
A huge thank you and great appreciation for Mark Walters and his very fine crew who smoothly removed the dead Slash Pine tree on the City's R-O-W abutting our property.

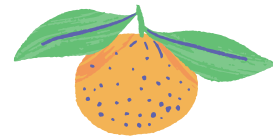
It gives me great pride in our City.
